## Competition Team Agreement 2021-2022

I hereby register \_\_\_\_\_ (Name of student) in class with K&C's Fab 5 studio

### Registration

- There is a \$25 registration fee per student or a \$40 registration fee per family due by August 4<sup>th</sup>.
- There is a \$100 costume deposit due by August 4<sup>th</sup>. Our general costume prices can range from \$150-\$200 depending on the type of routine your student will be doing.
- All students are required to purchase a studio shirt. We will be taking orders in September.

### Tuition- All tuition is due starting in September 2021 and ending in May 2022

#### check the tuition that corresponds with the class you are registering for:

- 1<sup>st</sup> year Novice \$58 per month for a 45 minute class.
- 2<sup>nd</sup> year Novice \$63 per month for a 1 hour class.

Novice tuition covers monthly tuition, 2 competitions, and recital fees for the student and parents.

- Beginning or Intermediate \$73 per month for a 1 hour class.

Beginning or intermediate tuition covers monthly tuition, 3 competitions, and recital fees for the student and parents.

- Advanced or Championship \$78 per month for an hour class.

Adv and Champ tuition covers monthly tuition, 3 competitions, and recital fees for the student and parents.

- Professional team tuition is \$95 per month. (This includes our pro alternate team members)

Pro tuition covers monthly tuition, 3 competitions, and recital fees for the student and parents.

- All competition students will be required to cover the cost of their Nationals competition fees. National's fees are \$19/event. These fees are due by February 2022.

\*\*All tuition also includes a 30 minute technique class which will be held on the 2<sup>nd</sup> or 3<sup>rd</sup> Friday of Oct, Nov, Jan, and Feb as well as any extra practices that may be needed.

I agree that payment for each month will be paid by automatic withdrawal the first Monday of each month from September 2021 through May 2022. I agree to pay any fees resulting from failure to get withdrawable payment. I understand that there is no credit or refund for lessons missed.

**By registering with K&C's FAB 5 clogging studio I agree to be supportive of the directors and teachers choices of music, choreography, and costumes. I understand that K&C's FAB 5 Studio has the right to refuse their services to anyone for any reason.**

I understand that if I choose to participate in a competition team I agree to the following: I agree to attend or have my child to every practice, performance, and competition. If a practice is missed the week before competition I understand K&C's FAB 5 Studio has the right to bench me or my child from the upcoming event. I understand that K&C's FAB 5 Studio has the right to keep a student from competing or performing if they feel that the student is not prepared. I understand that summer camps along with competing the All Around Solos are required and that the fee's pertaining to competition and camps are non-refundable.

As a parent (or student) I understand that there is a risk of injury or acquiring any illness while participating in any activities offered with K&C's Fab 5 Studio. "Activities" include all in-house activities, as well as off-site activities, including, but not limited to conventions, competitions, dress rehearsals, recitals, etc... I agree to release and hold harmless and forever discharge K&C's Fab 5 Studio, its officials, faculty and staff, agents, other employees or volunteers from any actions, suits, damages, claims or judgments that may result from personal injury that I or my child sustains while on the premises of Ziegfeld Arts Academy and at all off-site activities offered to your child. In case of injury or illness, I give permission for the above child(ren) to be transported to and receive medical treatment at a medical facility, and I guarantee the payment of all expenses incurred for such transportation and treatment.
